This will confirm the substance of my telephone conference
with Kathleen Johnson yesterday afternoon. The original and twelve
copies of this letter are hereby submitted for filing in the above
docket.

On November 13, 1996, Poinciana Utilities and the South
Florida Water Management District filed a Request for Expedited
Treatment of the above application. This was done given the
important public interest involved, and the significant lead time
necessary for the many stages of implementation of the proposed
extension of service to the Hatchineha Estates area, none of which
will be undertaken until PSC approval of the instant application is
obliterated.

Poinciana Utilities completed all notice requirements for the
application on November 13, 1996. It filed proof thereof on
November 26, 1996 through submittal of three affidavits. No
objections to the application have been filed and the time for
filing same has expired. Poinciana Utilities has also fully
responded to all staff requests for further information.

The current CASR schedules correction of deficiencies for
January 31, 1997, a February 6 Staff recommendation, and a February
18 agenda conference. As of December 6, 1996, all Staff-perceived
deficiencies were rectified.
