DISCUSSION OF ISSUES

ISSUE 1: Should ALLTEL Florida Inc.'s request to revise its concurrence statements for Local and Interexchange Private Line Service be approved?

RECOMMENDATION: Yes, ALLTEL Florida's request should be approved.

STAFF ANALYSIS: Except for Ringdown Circuit and Cable Pair Services, ALLTEL Florida, Inc. concurs in the rates, charges and regulations governing Local and Interexchange Private Line Service filed by BellSouth in its Private Line Services Tariff. On December 12, 1996 ALLTEL Florida Inc. filed a tariff, attached hereto as Attachment A, which revises its concurrence statements for Local and Interexchange Private Line Service. The changes are simply textual revisions, wherein ALLTEL added language to utilize the rates, charges and regulations as filed by BellSouth in its Private Line Services Tariff, and updated the tariff language of the Interexchange Private Line Service to reflect the new company and tariff names for BellSouth. Therefore, the revenue impact to the Company is zero. In addition, ALLTEL Florida, Inc. is proposing to grandfather its existing customers with Ringdown Circuit Service. This service will not be available to new

customers, but only to existing customers at their current locations. Again, the revenue impact to the Company is zero.

**ISSUE 2:** Should this docket be closed?

**RECOMMENDATION:** Yes. If Issue 1 is approved, this tariff should become effective January 11, 1997. If a protest is filed within 21 days from the issuance date of the Order, the tariff should remain in effect pending resolution of the protest. If no timely protest is filed, this docket should be closed.

**STAFF ANALYSIS:** If the Commission approves Issue 1, this tariff should become effective January 11, 1997. If a protest is filed within 21 days from the issuance date of the Order, the tariff should remain in effect pending resolution of the protest. If no timely protest is filed, this docket should be closed.

20.1.1 General (continued)

b Allowance for Interruptions

No allowance is made for interruptions of less than twenty four hours. For interruptions of twenty-four hours or more, credit is allowed for the proportionate part of the monthly charge in multiples of one day for each twenty four hours or major fraction thereof, for the portion of the facilities rendered inoperative by reason of interruption.
