to Cancel Certificate and Tariff

Dear Mr. D'Haeseleer:

IDB WorldCom Services, Inc. (IDB) is a subsidiary of WorldCom, Inc. d/b/a LDDS WorldCom ("LDDS"). The acquisition of IDB by LDDS was accomplished through a transfer of control transaction in 1994 with IDB Communications, Inc.

IDB provided resold intrastate interexchange services in Florida pursuant to Docket No. 93-1006-TI (12-21-93). However, IDB no longer provides such services within Florida. This letter is to request that IDB's Certificate of Authority and tariff for service in Florida be cancelled effective with the filing of this letter.

This cancellation of certification will not affect any customers in Florida. Over a period of time, IDB customers have either migrated to other services provided and tariffed by LDDS or have chosen other long distance carriers. IDB does not currently provide service to any customers in Florida.


