Dear Mr. Hill:

Commission Order No. PSC-96-0657-FOF-WS requires Indiantown Company, Inc. to make refunds to customers. The refunds are the result of a 1994 indexing for money collected after May 13, 1994.

My reading of Rule 25-30.360, F.A.C., suggests to me that the refund must be on a per customer basis to each customer who received service during the refund period. This, of course, will require a great deal of work on the part of the company. The refund will have to be manually calculated for every customer for each month for 26 months, since one of the rates reduced is a \$.02 per thousand gallons of water used rate and the other is a monthly BFC rate reduction dependent upon meter size. To add complication to the refund, interest must be applied monthly at a published rate to each month's refund.

Chuck, is there a simpler way to do this? Can you give us some easier way to accomplish the refund? For example, could we just calculate the total refund with interest at the highest rate during the entire term, divide that amount by the number of customers being served on the date of the Commission refund order, credit each such customer's bill on September 1st and provide a cash refund in like amount to any previous customer who requests

a refund, even though they were not on the system on May 10, 1996? If not, we request assistance under Rule 25-30.360(4)(e), F.A.C.


