Issue 1: Recommendation that Lenaca, Inc., Marie A. Baker, and Pay Phone Systems should have their certificates canceled for violation of Rule 25-24.520(1)(a) and (b), F.A.C., Reporting Requirements, if they fail to pay a \$100 fine and provide staff with the information required by the rule within 30 days after the order becomes final. The fines are to be paid to the Florida Public Service Commission and forwarded to the Office of the Comptroller for deposit in the General Revenue Fund pursuant to 364.285(1), F.S.

Issue 2: Recommendation that these docket be closed if no person whose substantial interests are affected files a protest within 21 days of issuance of the order. If no timely protest is filed, these dockets should be closed at the conclusion of the 30-day period after the order becomes final. If a company pays the \$100 fine and provides the information required, the docket should be closed. A protest of one docket should not prevent this order from becoming final for the other dockets.
