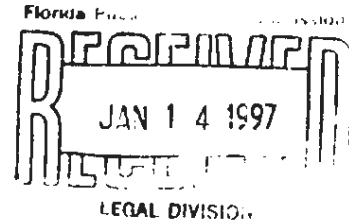

On May 8, 1996 the control became the responsibility of the property owners, all members of Fair Lane Acres, Inc. (a Corporation Not For Profit). N96000002442

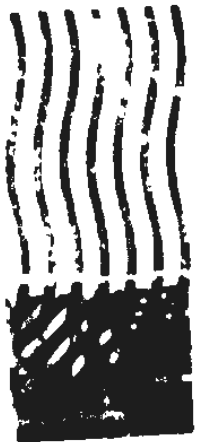
