A DISTANCE OF 249.08 FEET TO A POINT OF INTERSECTION WITH THE RIGHT OF WAY LINE OF S.W. 84TH AVENUE ROAD, THENCE NORTHEAST ALONG SAID RIGHT OF WAY THROUGH A CURVE CONCAVED TO THE NORTHWEST WITH A RADIUS OF 1583.98 FEET, A DELTA OF 04°30'35", A TANGENT OF 62.37 FEET, AND AN ARC LENGTH OF 124.68 FEET; THENCE NORTH 35°06'01"E.
