As argued in our pending "Motion for Reconsideration" and "Amended Motion for Reconsideration or Alternatively, Motion to Correct Computational Errors," these mathematical errors are believed to result in understated revenue requirements well in excess of \$700,000.

The meeting we propose would involve a careful review of the Commission Staff electronic spreadsheet/workpapers which we formally filed in the docket with copies to all parties last month.


Mr. Seidman, and an attorney from our firm, would attend on behalf of the utility.
