Dear Mrs. Bayo:

This letter is filed in connection with the February 13, 1997, filing by MCImetro of "Updates to MCImetro/BellSouth Interconnection Agreement," and AT&T's filing of a "Revised Attachment 15." With respect to MCIm's filing, the language submitted is, in fact, agreed language. However, there is a minor error in Section 2.3.1.9 of Attachment II. In the last sentence, the word "within" should be substituted for the word "with," and the sentence should read as follows: "MCIm shall be permitted to resell MULTISERV to multiple and different subscribers of MCIm for purposes of aggregation; provided, however, that the lines must be aggregated within the MCIm-defined common block." We have discussed this matter with MCIm's in-house counsel, Jeremy Marcus, who will make the change in the joint composite document.

With respect to AT&T's filing, the language AT&T filed for Attachment 15 is agreed language.


