(4)(d) The Commission shall exercise its exclusive jurisdiction in order to: (d) Promote competition by encouraging new entrants into telecommunications markets . . .

Regarding the showing of financial capability, the Finance staff has analyzed the unaudited financial statements of Orlando Digital Telephone Corporation (Orlando Digital) for the period ending December 31, 1995. An audit could change one's opinion of the company's financial condition. As the attached schedule shows, Orlando Digital has adequate liquidity, ownership equity, and profitability.

In this matter, Orlando Digital is asking for a certificate to provide alternative local exchange telecommunications service. Staff notes the limited nature of the application. For purposes of granting a certificate based on the financial information provided, the financial capability appears adequate.

The applicant attests to its financial capability to provide and maintain the proposed telecommunications service. Based on this showing, the applicant appears to meet the financial capability standard of Section 364.337, Florida Statutes.
