

## PUBLIC COUNSEL'S PRELIMINARY LIST OF ISSUES AND POSITIONS

The Office of Public Counsel hereby submits its preliminary list of issues and positions

pursuant to Order No. PSC-97-0350-PCO-EU:

- ISSUE: Would the Commission exceed its jurisdiction if it were to allow Tampa Electric to earn a return through retail rates for its wholesale sales to the Florida Municipal Power Agency (FMPA) and to the City of Lakeland?
- <u>OPC</u>: Yes. The Federal Power Act, 16 USC §§ 824, <u>et seq</u>., was enacted in 1935 to provide the federal regulation of electric utilities found to be outside the domain of state regulators in the case of <u>Public Utilities Commission of Rhode Island v. Attleboro Steam & Electric Co.</u>, 273 U.S. 83, 71 L.Ed.549, 47 S.Ct. 294 (1927). The Commission cannot invade FERC's jurisdiction even if it believes doing so will provide an incentive for electric utilities to provide retail service at the lowest reasonable cost. The Commission cannot cross the "bright line" drawn by Congress between state and federal jurisdiction. <u>Federal Power Commission v. Southern California Edison Co.</u>, 376 U.S. 205, 215-216 (1964) ("... Congress [in the Federal Power Act] meant to draw a bright line easily ascertained, between state and federal jurisdiction, making unnecessary [] case-by-case analysis ")
