**FLORIDA INDUSTRIAL POWER USERS GROUP'S  
JOINER IN PUBLIC COUNSEL'S MOTION FOR RECONSIDERATION**

The Florida Industrial Power Users Group (FIPUG) hereby files its notice of joinder in Public Counsel's motion for reconsideration and states:

1. On March 31, 1997, the Commission issued Order No. PSC-97-0359-FOF-EI (fuel order). In that order, the Commission permits Florida Power Corporation (FPC) to recover the costs for replacement fuel at its Crystal River 3 nuclear unit.
2. A review of the order demonstrates that it is not based on competent substantial evidence.
3. FIPUG adopts and incorporates Public Counsel's motion for reconsideration filed on April 2 and asks the Commission to reconsider that portion of the fuel order related to Crystal River replacement fuel.

WHEREFORE, FIPUG moves the Commission to reconsider its fuel order and


