Dear Ms. Bayo:

On March 28, 1997, Telecuba, Inc. filed with the Commission the rebuttal testimony of its president, Luis Coello, in the above-captioned docketed proceeding. In that testimony at page 8, Mr. Coello testified that he had arranged to have notices of the availability of refunds to holders of Telecuba calling cards published in El Nuevo Herald, a newspaper of general circulation in Miami, Florida. Attached to that testimony is Exhibit LC-2 consisting a copy of the notice and the affidavit of publication of the notice on March 20, 21, and 22, 1997. 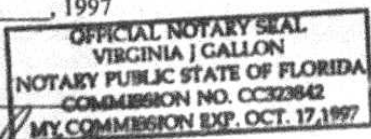
