On August 14, 1996, Thomas W. Hart registered a complaint against Florida Power & Light with the Division of Consumer Affairs. Mr. Hart felt that he was unjustifiably charged with current diversion, and he disputes the amount rebilled to his account. On February 24, 1997, the Commission issued Order No. PSC-97-0215-FOF-EI, Notice of Proposed Agency Action Order Denying Complaint. Mr. Hart timely filed a Petition on Proposed Agency Action to protest the Order.

Based on the foregoing, Staff recommends that this matter be set for hearing. Because the issues will be primarily factual, Staff recommends that this case be referred to the Division of Administrative Hearings.
