I will be out of town on April 15, 1997, the day of the meeting pertaining to the above docket, but I would like to submit my testimony.

First an itemized statement should have been sent to each of the 140 customers, automatically, not upon request.

According to the notice sent, of the \$15,720. loss, the increase is proposed at \$15.74 per month to each customer. The actual loss from each customer was \$9.357.

I believe that the increase should be no more than \$10 per month. There are several low, fixed income persons living in Eastside Village. Our social security cost of living increase was minimal. In fact we have less money to live on with all the increases on our fixed expenses, this year.

I make a motion that each of the 140 customers receive, by mail, an itemized statement of how the increase ~~loss~~ was arrived at before any final decision on the staff's rates. Also, each year an itemized statement should be sent and discussed for any loss or profit. If there is a profit, it should be divided by the customers, equally.

I will be looking for the statement from you, upon my return.




