In response to your letter concerning Docket No. 970117WU we are providing this additional information.

1. Revised legal description is enclosed.
2. Revised map is enclosed.
3. There will be no changes to the monthly rates or the service availability charges for the extension of service to the proposed territory.
4. Marion Utilities, Inc. has an annual return on investment of approximately \$78,000.00. We maintain reserves of approximately \$100,000.00. The proposed cost of the extension will be minimal (\$9,000) so it will not impact our financial position in a negative way.
5. We are enclosing new tariff sheets.
6. Our certificate was included in the letter of reply in Docket No. 970119WU.
7. The design capacity of the proposed extension is 1400 GPD. The peak flow at the providing plants is 461 GPD.
