The enclosed Income Statement and Balance sheet of Wireless One Network, L.P. are forwarded with a request for confidentiality of said information, as applicants wireless telephony business is subject to present competition from GTE Wireless and Next-Tel, and imminent prospective competition from PrimeCo, BellSouth Mobility, Sprint Spectrum, AERIAL (division of Telephone and Data Systems), and Alltel Mobile, among others, and its prospective ALEC and IXC operations will likewise compete against established highly capitalized entities.

Applicant, A Delaware Limited Partnership has labeled a completed set of statements **CONFIDENTIAL**. A second set of statements devoid of monetary amounts is enclosed for the public file.

These statements represent the entire financial history of the applicant.

Applicant's 99.75% owned Delaware Limited Partnership, Wireless One Holding Company, L.P. obtained Federal Communications Commission authorization for and took control of Florida Cellular RSA Limited Partnerships cellular and microwave interests in southwest Florida on January 22, 1997.

Florida Cellular RSA Limited Partnership was dissolved at that time. It's majority owners desire confidentiality of the financial history of said partnership.

The principals of WON, Inc., the General Partner and .25% owner of Wireless One Network, L.P. were officers of the predecessor Florida Cellular RSA Limited Partnerships


