

Schedule "A"

Definitions

The following definitions apply to this schedule:

1. And/Or. The conjunctions "and" and "or" shall be construed either disjunctively or conjunctively as necessary to bring within the scope of the discovery request all responses that might otherwise be construed to be outside of its scope.
2. Application. The term "Application" means the Application for amendment of Certificate No. 427-W to add territory in Marion County by Windstream Utilities Company, together with all documents pertaining to the Application and the instant proceedings before the PSC.
3. Communication. The term "communication" means the transmittal of information (in the form of facts, ideas, inquiries or otherwise) in any direct or indirect manner. When testimony regarding a communication is requested, the request includes the identity of all participants to the communication, whether the communication was written or oral, the date of the communication and the substance of the communication.
4. Concerning. The term "concerning" means relating to, referring to, describing, evidencing or constituting.
5. County. The term "County" means Marion County, Florida.
6. Dlouhy. The term "Dlouhy" means Butch and/or Shari Dlouhy.
7. Document. The term "Document" is intended to include and does include any and all kind of written, typewritten, printed, pictorial or recorded material whatsoever, both original in form and copies thereof, including, but without limitation, plans, construction documents, specifications, drawings, notes, transcripts of notes, memoranda, letters,

telegrams, publications, agreements, pictures, blueprints, schematics, contracts, tape recordings, transcriptions of recordings, log books, contracts, microfiche recordings, ledgers, invoices, delivery tickets, change orders, work orders, purchase orders, canceled checks, correspondence, interoffice and intraoffice memoranda or communications, action request forms, speed memos, directives, instructions, orders, rules, investigations and/or reports thereof, applications, orders, rules, amendments, supplements, endorsements, modifications, errata sheets, records of examinations, assessments, stipulations, instruments, leases, purchase options, telephone log books, diaries, and all other written, typewritten, printed, pictorial or recorded material of similar description. A draft or non-identical copy is a separate document within the meaning of this term.

"Document" includes all intra-party documents to the party to whom this request is directed and all documents provided to firms, businesses, entities and individuals external to the party to whom this request is directed.

8. Person. The term "person" includes individuals, corporations, partnerships, other business or charitable associations or entities and any government or governmental body, commission, board or agency.

9. Pertaining. The term "pertaining" includes relating to, appertaining to, applying to, bearing upon, to being connected to and/or having reference to.

10. Property Owners. The term "property owners" means persons owning or having a possessory interest in any real property within or adjacent to the territory that is the subject of the Application herein.

11. Provided. The term "provided" includes mailed, delivered, submitted, conveyed, surrendered, communicated, sent, uttered and/or supplied.

12. PSC. The term "PSC" means the Florida Public Service Commission

13. Singular/Plural. The use of the singular form or any word includes the plural and vice versa.

14. Subject Area. The term "Subject Area" means the existing Windstream Utilities certificated area, proposed additions or amendments to certificated area, and areas adjacent or proximate to the certificated area.

15. Windstream. The term "Windstream" means Windstream Utilities Co., Inc., and any of its officers, directors, employees, agents, shareholders, servants, subcontractors, predecessors-in-interest, successors-in-interest, subsidiaries, parent companies, or any other entity relevant to the Application in these proceedings.

16. You/Your/McDonald. The terms "you," "your," or "McDonald" mean George McDonald.

When a person or party is referred to, such reference herein includes the person's agents, subsidiaries, parents, affiliates, attorneys, representatives or persons acting on his, her or its behalf.
