PURPOSE AND PROCEDURE

The purpose of this hearing shall be to permit Tampa Electric Company to present its testimony and exhibits regarding the determination of appropriate cost allocation and regulatory treatment of total revenues associated with wholesale sales to FMPA and City of Lakeland by Tampa Electric Company; to permit any intervenors to present testimony and exhibits concerning this matter; and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony. The proceedings will be governed by the provisions of Chapter 120, Florida Statutes, and Chapter 25-22, Florida Administrative Code.

A prehearing conference will be conducted at the following time and place:


