BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request For Specified Confidential Classification for the PATS Access Lines Quarterly Report.

1. In a Memorandum dated September 23, 1991, the Florida Public Service Commission ("Commission"), requested that all local exchange companies submit pay telephone data on a quarterly basis for both LEC and NON-LEC pay stations.

2. BellSouth filed its most recent response to this request on April 21, 1997. At that time, BellSouth also filed a Notice of Intent to Request Confidential Classification.

3. BellSouth is filing this Request for Confidential Classification because the information contained in this quarterly report is clearly confidential and proprietary, and therefore, entitled to confidential classification pursuant to Sections 119.07(3)(w) and 364.183, Florida Statutes.
