
The purpose of this letter is to advise the Commission of the recent name and address change of International Telecommunications Corporation ("ITC"), which holds authority to resell intrastate interexchange telecommunications services in the State of Florida. Earlier this year, ITC changed its corporate name to RSL COM U.S.A., Inc., and moved its corporate headquarters to 5550 Topanga Canyon Boulevard, Suite 250, Woodland Hills, CA 91367. The company also moved its Florida office, to 6300 NW Fifth Way, Suite 100, Fort Lauderdale, FL 33309.

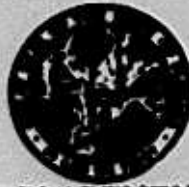
