Dear Mr. Hope:

This letter is to follow up our conversation of May 12, 1997. As I stated yesterday, if you pay the City of Alachua the refund owed to the customers for the miscellaneous service charges, the late fee and the interest on the customer deposits without prior approval of the Public Service Commission, you will be in violation of Order No. PSC-93-1769-FOF-WS. Since the order requires a refund to the customers, prior to making any payment to the city, you must send a letter requesting the Commission's approval to deviate from the order. This request will be brought to the Commission for a decision at the earlier opportunity. You will be advised of when we will take your request to the Commission and we will send you a copy of the recommendation.

If this is what you wish to do, please send a letter that explains why you would rather make a payment to the city than to the customers. If you do not send a letter with such a request, and make a payment to the city, you will be in violation of the above order. Violation of the order may result in show cause proceedings.

If this is indeed the case, please send a letter explaining how much interest you would be willing to refund, how it would be divided between the customers and when you would expect to complete the refund with interest.
