

This deposition will be taken upon oral examination before an official court reporter or other officer authorized by law to take depositions. The oral examination will continue from day to day until completed. By agreement with the Staff of the Florida Public Service Commission the deposition will continue over to June 5, 1997, if necessary. The deposition will be taken pursuant to Rule 1.310, Fla. R. Civ. P. for the purpose of discovery, for use at trial, or both, or for such other purposes as are permitted under the applicable and governing rules.


The deponent is requested to bring with him to the deposition:


