**NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION**



The Quarterly CISR Report contains proprietary confidential business information regarding contractual matters which would cause irreparable harm to Gulf Power Company and the entity with whom it has contracted if such information is disclosed to the general public. The Quarterly CISR Report also contains information relating to competitive interests and trade secrets which would cause irreparable harm to Gulf Power Company and the entity with whom it has contracted if such information is disclosed to the general public. The information for which confidential classification is sought is intended to be and treated by Gulf Power Company as private. A formal request for confidential classification will be filed within the time period specified in Rule 25-22.006(3)(a), Florida Administrative Code, if the Staff determines that the
