
Dear Ms. Clark:

I am writing on behalf of members of the Florida Prison Action Network who have contacted me regarding the Public Service Commission's findings with regard to the overcharges made by MCI. I must agree with Ms. Gayle Russell of FPAN that the overcharges should be refunded to those who were overcharged---not deposited in the General Revenue Fund.

I am very concerned that this action is even being considered. If this was our money, we would be (and rightfully so) very upset that the state was not only not going to make MCI refund it but that the investigating agency was actually going to keep it! I hope the PSC is rethinking this action.

I am asking for your support in seeing that MCI properly refunds the money.
