Dear Ms. Bayo:

The P.U.L.S.E. Organization is officially objecting to the closing of Docket No. 960502-GU and Order No. PSC-97-1011-FOF-GU. P.U.L.S.E.'s objections are based on the following reasons:

1. We are concerned that falsifying of City Gas reports and records go back as far as seven years or more. All individuals involved with falsifying company records have not been terminated. We have been told that Rick Wall is also Responsible for falsified reports to the P.S.C. This must be investigated, not by City Gas, but by the P.S.C.
2. Present and past staffing levels are inadequate. Present staff has told us that the company is falling behind in required leak surveys and valve maintenance in Miami. We question the quality of work being performed by City Gas.

We are petitioning the P.S.C. to allow our organization to produce additional facts to support our charges against City Gas in a timely manner. If you have any questions, you may contact our office at (305) 576-7590.
