RE: Docket No. 960288-SU - Application for approval of reuse project plan in Seminole County by Alafaya Utilities, Inc.

In order to fully evaluate the several service options for providing reuse service which the utility has proposed for consideration in this docket, and to allow for time to conduct a customer meeting to discuss and obtain customer input on staff's preliminary recommendation concerning these options, staff has rescheduled the filing of the recommendation in this docket to November 20, 1997. The recommendation was previously scheduled to be filed on August 7, 1997. The utility has waived the statutory deadline for the Commission to make its PAA decision in this docket for an additional six months, until March 11, 1998. Given these timeframes, we will be unable to obtain all prefiled testimony in time for a January, 1998, hearing. For these reasons, we would like to reschedule the shadow hearing dates. Therefore, we are requesting that the Chairman:

- 1) Cancel the shadow Prehearing Conference scheduled for January 5, 1998; and
- 2) Cancel the shadow Hearing scheduled for January 28, 1998.
