("BellSouth") agreed to undertake several action items as a result of the public hearings in the above captioned docket held in Key West on October 3, 1997. BellSouth's report on these action items will be given on the stand by Dan Baeza, BellSouth's witness, at the Hearing on October 13, 1997. The action items deal with whether the Keys could be given sufficient NXX codes to delay implementation of an overlay in that area, whether the Keys could be changed to a new area code, the possibility of a concentrated growth overlay, and the procedure for operators of 411 and 305-555-1212 if an overlay is implemented.
