



Applicants for authority to provide telecommunication service in Florida.

Pursuant to Section 364.337 (1)(3) and 364.339 (2), Florida Statutes, effective July 1, 1995, all applicants must have sufficient technical, financial, and managerial capability to provide such service before a certificate of public convenience and necessity can be granted to conduct alternative local exchange, interexchange telecommunications or shared tenant services in Florida:

Regarding the showing of financial capability, the following applies:

The application should contain the applicant's financial statements, including:

1. the balance sheet
2. income statement
3. statement of retained earnings for the most recent 3 years.

Further, the following documentation regarding financial capability should be provided.

1. Please provide documentation that the applicant has sufficient financial capability to provide the requested service in the geographic area proposed to be served.
2. Please provide documentation that the applicant has sufficient financial capability to maintain the requested service.
3. Please provide documentation that the applicant has sufficient financial capability to meet its lease or ownership obligations.

NOTE: This documentation may include, but is not limited to, a projected profit and loss statement, credit references, credit bureau reports, and descriptions of business relationships with financial institutions.

If available, the financial statements should be audited
financial statements.

If the applicant does not have audited financial statements,
it shall be so stated. The unaudited financial statements should
then be signed by the applicant's chief executive officer and chief
financial officer. The signatures should attest that the financial
statements are true and correct.

If you have already forwarded an application for certification
to this Commission, this information request is **in addition** to the
information that was requested in the application.

As soon as we receive this information we will proceed with
your application.
