Dear Ms. Brubaker:

The following are Florida Cities Water Company's (FCWC) responses to questions posed in your letter of September 12, 1997. For clarity we have included the question in addition to our response.

1. Q. What has FCWC's policy been in the past with regards to the installation of line taps, service meters and cross-connection control devices for private fire protection service customers for Lee County South Ft. Myers, customer? What has the policy been for other FCWC systems? Please explain the policy for each system.

A. It has been and continues to be FCWC's policy that the developer install line taps, valves, fire meters and cross-connection control devices associated with a fire line that would ultimately provide private fire protection service. This policy has been applied throughout the entire company.

2. Q. Does FCWC believe that it is appropriate for the developer to pay for the line tap for the installation of service meters and cross-connection control devices for private fire protection? If so, please explain why.

A. Yes, FCWC believes that it is the developer's/customer's responsibility to install the necessary infrastructure to provide private fire protection to a structure. The developer/customer is

the sole beneficiary of the private fire protection system. In addition to the obvious benefit of minimizing fire damage, the developer enjoys an economic benefit associated with lower insurance rates. Customers that do not have private fire protection do not enjoy these benefits and should therefore not pay for such.

3. Q How many times in the past has FCWC had a request for this type of service which resulted in the service being provided?

A. It is unknown how many requests for private fire protection services have been made historically. Presumably all private fire protection service customers at some point requested service.
4. Q Does FCWC always consider the installation and cost for private fire protection to be the responsibility of the building contractor?

A. As stated in response #2 above, FCWC considers the installation costs associated with the provision of private fire protection service the responsibility of the developer/customer requesting the service.
5. Q Has FCWC performed any installations for private fire protection? If so, what was the charge and how was the charge calculated?

A. No.
6. Q If FCWC has not performed any installations, what would FCWC charge for the installation and how would the charge be calculated?

A. Based on the current tariff (Sheet 33.0, 1. (b) attached for your reference), FCWC would charge actual installation costs. Additionally, it is not clear whether FCWC could install the system, a licensed fire sprinkler contractor may be required.
7. Q Are all private fire protection customers metered? If not, please explain why. Please provide a list of all private fire protection customers by line size/meter size showing those that are and are not metered.

A. All new private fire protection customers are metered. The vast majority of existing private fire protection customers are metered. There are some older installations where a meter was not installed and FCWC has, at this point, not required the customer

to retrofit a meter into the system. A list of existing fire protection service by line size is attached. The size of the fire line is listed in the column labeled "FIRE LINE" and is coded as follows:

A: 1 ½"	E: 4"
B: 2"	F: 6"
C: 1"	G: 8"
D: 3"	H: 10"

The column labeled "METER LOCATION" indicates where on the property the meter is located. Those accounts which do not have a location do not have meters. This information is based on our Customer Information System and was not field verified at this time.

8. Q. In reference to Tariff Sheet No. 38.0, why does FCWC not have a meter installation charge for its water customers?
- A. After researching Company records it is unknown why FCWC does not have a meter installation charge for its water customers in Lee County Division.
