AMENDATORY ORDER

BY THE COMMISSION:

On October 13, 1997, this Commission issued Order No. PSC-97-1233-AS-WS, approving the utility's offer of settlement in both the show cause proceeding and the limited proceeding which had been consolidated for purposes of hearing. In its heading, the Order specifically references Docket No. 961471-WS; however, the Order also should have referenced Docket No. 970125-WS. In addition, after issuance, a scrivener's error was noted in the Order.

Because the sentence under the heading "Closing of Docket" on page 6 did not specifically reference Docket No. 970125-WS, it is amended to read:

Upon expiration of the protest period, if a timely protest is not received from a substantially affected person and upon verification that the utility has reduced its rates pursuant to its settlement offer, Docket No. 970125-WS shall be closed. Furthermore, upon verification that the utility has remitted the \$1,000 fine, Docket No. 961471-WS shall be closed.

Accordingly, the last ordering paragraph on page 7 is amended to reference Docket No. 970125-WS as well and shall read:

ORDERED that in the event this Order becomes final, and upon verification that the utility has reduced its rates

pursuant to its settlement offer, and upon the utility's filing of and our staff's approval of the proposed customer notice and the revised tariff sheets, Docket No. 970125-WS shall be closed. It is further

Finally, an additional ordering paragraph shall be inserted: "ORDERED that upon verification that the utility has remitted the \$1,000 fine, Docket No. 961471-WS shall be closed."


Order No. PSC-97-1233-AS-WS is affirmed in all other respects.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-97-1233-AS-WS is hereby amended as set forth in the body of this Order. It is further

ORDERED that Order No. PSC-97-1233-AS-WS is affirmed in all other respects.
