RE: Docket No. 971192-WS Application for Grandfather Certificates to operate a Water and Wastewater Utility, in Polk County by Bieber Enterprises Inc. d/b/a Breeze Hill Utilities.

Dear Mr. Bieber:

After reviewing the application in the above referenced docket, the staff has identified the following deficiencies. Please correct and/or provide additional information as requested.

1. Rule 25-30.035(4), Florida Administrative Code, requires that the date the utility was established should be provided. Please provide the date the utility was establish for both systems.
2. Rule 25-30.035(9), Florida Administrative Code, requires a description, using section references as specified in Rule 25-30.030(2). The map description of the territory section refers to section 37, but there is no section 37 listed on the map.
3. As required by Rule 25-30.035(10), Florida Administrative Code, provide a copy of the detailed system map showing the lines, treatment facilities and the territory to be served.
4. As required by Rule 25-30.035(11), Florida Administrative Code, please provide a copy of the official county tax assessment map showing the service area.
5. As required by Rule 25-30.035(6), Florida Administrative Code, please provide evidence that the utility owns the land upon which the utility treatment facilities are located, or a copy of an agreement which provides for the continued use of the land, such as a 99-year lease. The Commission may consider a written easement or other cost-effective alternative.
6. Please provide a copy of the County approved rates for the utility and any approved service availability charges.


