A copy of the Quarterly CIS Rider Report is attached hereto as exhibit "A".

The Quarterly CIS Rider Report contains proprietary confidential business information regarding contractual matters which would cause irreparable harm to Gulf Power Company and the entity with whom it has contracted if such information is disclosed to the general public. 
