- I) DOCKET NO. 971311-EI - Application Florida Power Corporation to issue and sell commercial paper backed by, or borrowings under, the Company's Long-Term Credit Agreements not to exceed \$400 million and other long-term securities and debt obligations not to exceed \$830 million during the twelve months ending December 31, 1998. In addition, the Company requests authorization to issue and sell short-term unsecured borrowings and commercial paper in an aggregate amount not to exceed \$500 million, which amount shall be in addition to and in excess of the authority conferred on the Company by Section 366.04, F.S., to issue short-term securities aggregating not more than five percent of the par value of the Company's other outstanding securities.

- J) DOCKET NO. 971304-EI ← Application of Florida Power & Light Company (FPL) for approval to issue, sell and/or exchange any combination of long-term debt and equity securities and/or to assume liabilities or obligations as guarantor, endorser or surety in an aggregate amount not to exceed \$1.3 billion during the twelve months ending December 31, 1998. FPL also seeks authority to enter into forward refunding or forward swap contracts during calendar year 1998, and in conjunction with these forward contracts, FPL seeks authority to issue and sell up to \$151 million of securities through December 31, 2002. In addition, FPL seeks authority to issue and sell short-term securities during the calendar years 1998 and 1999 in an amount or amounts such that the aggregate principal amount of short-term securities outstanding at the time of sale will not exceed 25% of FPL's gross revenues during the preceding twelve months of operation.
- K) DOCKET NO. 971389-GU ← Application of City Gas Company of Florida (a division of NUI Corporation) for authority for NUI Corporation to issue and sell long-term debt and equity securities in amounts not to exceed \$30 million in the aggregate during the twelve-month period beginning November 15, 1997 or as soon thereafter as possible and ending September 30, 1998, and also for authority for NUI to issue short-term debt not to exceed 25% of the par value of other outstanding NUI securities during the same period. The application should become effective the day of the scheduled Commission conference, resulting in an effective period of November 18, 1997 through September 30, 1998.

Issue: Recommendation that the Commission approve the action requested in the dockets referenced above and close these dockets.
