AMENDATORY ORDER

BY THE COMMISSION:

On November 3, 1997, this Commission issued Order No. PSC-97-1395-FOF-WU. After issuance, an error was noted in the Order. The Order states that the docket shall be closed in the event a timely protest was not filed. However, we voted to close the docket upon expiration of the protest period, upon the utility's timely filing of revised tariffs consistent with our decision, and upon staff's verification of the revised tariff sheets.

To correct this error, the last ordering paragraph on Page 4 of Order No. PSC-97-1395-FOF-WU should read: "ORDERED that this docket shall be closed upon expiration of the protest period, upon Crystal River Utilities, Inc.'s timely filing of revised tariff sheets, and upon staff's verification that the tariffs reflect the decision herein."

We note that the protest period has expired and no protests were filed. Upon completion of all of the requirements discussed above, this docket shall be closed. Order No. PSC-97-1395-FOF-WU is affirmed in all other respects.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-97-1395-FOF-WU is amended as set forth in the body of this Order. It is further

ORDERED that Order No. PSC-97-1395-FOF-WU is affirmed in all other respects.


