BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request For Specified Confidential Classification for the monthly surcharge to support Florida's Telecommunications Relay Service.

1. In a Memorandum dated October 30, 1997, the Florida Public Service Commission ("Commission"), requested that BellSouth provide by month the number of access lines, by ALEC, for which BellSouth has made payments to Florida's Telecommunications Relay Service.

2. On November 24, 1997, BellSouth filed a Notice of Intent to Request Confidential Classification.

3. BellSouth is filing this Request for Confidential Classification because the information contained in this response is clearly confidential and proprietary, and therefore, entitled to confidential classification pursuant to Sections 119.07(2)(r) and 364.183, Florida Statutes.

4. BellSouth has appended to this Request for Confidential Classification as "Attachment A" a list of the location in the response of the information designated by BellSouth as confidential.

5. Appended hereto as "Attachment B" is two copies of the requested documents with the confidential information deleted.
