



The Act also states that state commissions may adopt regulations to advance and preserve universal service, so long as the state regulations are consistent

The Florida Commission intends to address these matters, to the extent possible, through its proposed agency action procedure at the May 19, 1997, Agenda Conference.

Due to the abbreviated hearing schedule in this docket, parties must present any objections to the Florida Commission's proposed agency action immediately. No additional protest period is possible. Therefore, parties must file any protests on or before the May 19, 1997 Agenda Conference. If any protest is received, parties participating in the hearing must file testimony as scheduled on May 21, 1997. 
