Dear Sirs,

On March 15th I attended the meeting at Port St. Joe regarding the restructure of rates proposed by St. Joe Natural Gas Company, Inc.

As you know, the paper mill is closing on April 1st for an indefinite period of time. The economy of Gulf County is built around Stone Container and with the closing of the mill, the outlook for the county is bleak. It is unfortunate that the wage scale is such that many wage earners live from pay day to pay day and have limited resources to fall back on. If you question this statement, you might check with the utility companies to see how many customers allow water, gas, power, and phone bills to lapse.

I believe that raising rates by the gas company would be a devastating blow to the people who are left behind after the anticipated exodus of workers and their families is complete. Rising taxes and a rising cost of living make it harder and harder for working people with growing families and retirees who want to live in Gulf County to meet their needs.

Please hear us now. You were good enough to hold a meeting, now listen to what we have to say about the proposed increase in gas rates.
