

The purpose of this letter is to advise the Commission of the recent name and address change of Intelco, Global Information Services, Ltd. ("Intelco GIS"), which holds authority to resell intrastate interexchange telecommunications services in the State of Florida. Earlier this year, Intelco GIS changed its corporate name to RSL COM PrimeCall, Inc., and moved its corporate headquarters to 100 Wall Street, New York, NY 10005.
