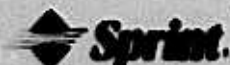

Dear Ms. Bayo:

Enclosed are a check for \$100.00 and the original and seven (7) copies of Sprint-Florida, Incorporated's application for a certificate to provide pay telephone service (PATS)

Sprint-Florida, Incorporated recognizes that Chapter 364 exempts the local exchange company from certification requirements, at least insofar as the provision of PATS located within the LEC's certificated territory. Although the Company does not concede that Sprint-Florida, Incorporated's Certificate No. 22 limits our authority to provide fully competitive deregulated PATS on a statewide basis, we are willing to submit to certification in an abundance of caution. At this time Sprint-Florida, Incorporated has not decided whether deregulated PATS will be provided on a structurally separate or accounting basis. Neither FPSC or FCC regulations requires a particular method of providing this service. In either case the PATS certificate could be utilized for provision of the services.
