AS A RETIRED HOMEOWNER WHO RECENTLY HAS HAD A NEW
HOME BUILT IN SEC. 22, IT WOULD ENTAIL AN EXTREME FINANCIAL
BURDEN FOR US TO ASSUME THE COSTS INVOLVED IN THE INSTALLA-
TION OF WATER AND SEWER SERVICE TO OUR PROPERTY -- PARTICULARLY
AFTER PAYING A CONSIDERABLE SUM FOR WELL, SEPTIC AND
