ORDER GRANTING MOTION FOR CONSOLIDATION

On October 22, 1997, Attorney General Bob Butterworth, on behalf of the Citizens of Florida through the Public Counsel, filed a Complaint alleging that LCI International Telecom, Corp., (LCI) through its employees or agents, changed the primary interexchange carrier of Mr. David Howe without his authorization or consent.

On December 3, 1997, LCI filed a Motion to Consolidate this Complaint with Docket No. 971437-TI. In its Motion to Consolidate, LCI asserted that the Commission has opened Docket 971487-TI, a show cause proceeding that will encompass all slamming complaints filed against LCI with the Commission during 1997. As such, the Complaint in Docket No. 971403-TI would be resolved by Docket No. 971487-TI. Both the Attorney General and the Public Counsel agree that Dockets Nos. 971403-TI and 971487-TI should be consolidated.

After reviewing the Complaint and LCI's motion, I find that it is appropriate, pursuant to Rule 25-22.035(2), Florida Administrative Code, to consolidate this docket with Docket No. 971487-TI, Initiation of show cause proceedings against LCI International Telecom Corp., for violation of Rule 25-4.118, Florida Administrative Code, Interexchange Carrier Selection. Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code.
