Dear Mr. Rosenberg:

I received your application for pay-telephone certification dated January 2, 1998. Your pay telephone certificate #2579 was cancelled for non-payment of the regulatory assessment fee for 1996. In 1996, your certificate was scheduled to be cancelled for non-payment of the 1995 regulatory assessment fee, but you paid the delinquent fee plus a \$250 fine.

According to Rule 25-4.0161(3), Regulatory Assessment Fees; Telecommunications Companies; "Telecommunication companies that owed gross regulatory assessment fees of less than \$10,000 for the preceding calendar year shall pay the fee and remit the appropriate form once a year. The regulatory assessment fee and appropriate form shall be filed no later than January 30 of the subsequent year for the current calendar year operations."
