

This is to inform you that TransAmerica Communications, Inc., 2103 N.W. 60th Circle, Boca Raton, Florida 33496 ("TransAmerica"), granted certification as a telecommunications carrier by Order No. 25623 dated February 13, 1992 in Docket No. 911121-TI, has had a change in control of ownership.
