299-W in Clay County; Request for Refund of Filing Fee

On March 4, 1997, the Commission received an application requesting approval to transfer Certificate No. 299-W from Duval Utility Company (Duval or utility) to Sun Coast Utility (Sun Coast.) Prior to completing the deficiency corrections for that application, Duval and Sun Coast decided to transfer the utility facilities to the Clay County Utility Authority rather than proceeding with the previously requested transfer. On August 29, 1997, the Commission received a new application from Duval requesting approval to transfer the water facilities to the Clay County Utility Authority and cancellation of Certificate No. 299-W.

Sun Coast paid a \$750 filing fee for the first transfer application, however, no filing fee is required for an application to transfer the utility to a governmental agency. Consequently, Sun Coast has requested a refund of the \$750 filing fee. I have attached a copy of Sun Coast's check showing payment of the filing fee and its letter requesting a refund for your reference.

Commission practice has been to refund a filing fee if no significant time and effort have been spent on the case. The staff assigned to this docket spent little time and resources processing it prior to the utility's decision to transfer the utility to the County rather than to Sun Coast. We believe it is appropriate and consistent with past Commission practice to refund the filing fee in this case. Therefore, we are requesting that you refund the filing fee to Sun Coast.
