### ISSUES AND POSITIONS

Issue 1: What is the appropriate final purchased gas adjustment true-up amount for the period April, 1996 through March 1997?

FPU's Position: \$562,942 over-recovery.

Issue 2: What is the estimated purchased gas adjustment true-up amount for the period April, 1997 through March, 1998?

FPU's Position: \$420,363 under-recovery.

Issue 3: What is the total purchased gas adjustment true-up amount to be collected during the period April, 1998 through March, 1999?

FPU's Position: \$142,590 over-recovery.

Issue 4: What is the appropriate levelized purchased gas cost recovery (cap) factor the period April, 1998 through March, 1999?

FPU's Position: 49.293 cents-per-therm.

<u>Issue 5</u>: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

The factor should be effective for all meter readings on or after April

1, 1998, beginning with the first or applicable billing cycle for the ATE
period April, 1998 through March, 1999.
