KTNT'S MOTION FOR EXTENSION OF TIME FOR FILING TESTIMONY

KTNT Communications, Inc. d/b/a I Don't Care and d/b/a It Doesn't Matter (KTNT) hereby requests an extension of time in which to file its direct testimony in this docket. As grounds for this Motion, it states as follows:

1. The Order on Prehearing Procedure (Order No. PSC-98-0207-PCO-TI) was issued on February 3, 1998. It set the time for applicant's direct testimony to be filed as February 6, 1998.

2. Perhaps because KTNT's counsel's offices are being relocated counsel did not receive the order on prehearing procedure.

3. KTNT needs an extension until Friday, February 13, 1998,

to file the direct testimony. KTNT does not object to affording intervenors a similar extension for filing their direct testimony. These extensions should not require rescheduling of the hearing.

4. Counsel for the Citizens of the State of Florida does not object to this extension. Undersigned counsel has not spoken with counsel for Attorney General, but will apprise the Prehearing Officer if the Attorney General has any objection.

WHEREFORE, KTNT respectfully moves the Prehearing Officer to grant it an extension to file its direct testimony until Friday, February 13, 1998.


