## AT&T'S AMENDED Prehearing Statement

AT&T Communications of the Southern States, Inc. (hereinafter "AT&T"), pursuant to Rule 25-22.038, Florida Administrative Code, and Order No. PSC-98-0090-PCO-TP, filed its Prehearing Statement in the above referenced docket on February 20, 1998. In reviewing the filed copy two errors are apparent in AT&T's Prehearing Statement. AT&T accordingly submits its amended Prehearing Statement to notify parties of the following corrections.

2. AT&T's position on Issue 5 was incorrectly stated. The corrected position is as follows:

**ISSUE 5**: If the answer to either part or both parts of Issue 4 is yes, how is the price(s) determined?

Position: The prices for UNE combinations are the costbased UNE rates established by the Commission and as set forth in the AT&T/BellSouth Interconnection Agreement regardless of whether such combinations recreate a BellSouth service. There is no basis in the Interconnection Agreement, the Commission's orders, the 8<sup>th</sup> Circuit's decisions, or the Telecom Act of 1996 to suggest that the prices of combinations of UNEs could be priced at anything other than the cost-based UNE rates established by the Commission. See Issue 6.

3. AT&T regrets any confusion caused the errors in its Prehearing Statement.
