After reviewing your letter dated February 5, 1998, and checking the pay telephones listed, I trust the following will resolve any issues or concerns.

Phone 850-469-9962 2905 E. Cervantes Pensacola Items: 6 14 22 24

Item 6: This one has me confused. I inspected the location after receiving your letter and the directory was there. I carry current directories with me and replace them as necessary when I service or collect from the phones.

Item 14: Since receiving my certificate I have filed for and received a Fictitious Name of Trident Communications from the State of Florida and an Occupational License from Santa Rosa County. Please forward a copy of this letter to your records department. The records can be updated from "Derrell Fagan" to "Derrell Fagan dba Trident Communications" if your department sees a need to do so. However, I do not want any confusion caused with the State Revenue Department on existing tax numbers, or with the Federal Authorities on FEIN numbers, tax filings, etc.

Item 22: Complaint verified and corrected.

Item 24: Item eliminated per our phone conversation.

Item 14: Same as above.

Item 16: I am confused on this one as well. I have enclosed a copy of both the upper and lower cards. I have marked the dialing instructions for your review. I designed these cards to approximate the information location and content to be consistent with the BellSouth cards.

Item 17: Again I find myself at a loss. I am under the impression that exceptions must be filed and approved by the state for any service not available. Since that is not the case here, I am not really sure what is expected.

Item 22: Complaint verified and corrected.

Item 29: I could not verify this complaint. These phones (850-489-9952 and 850-939-9567) are operated by the same register file that directs 0-, 0+ local, and 0+ intralata to the LEC. I was surprised to see this item appear on one and not the other. After receiving your letter, I inspected the phone and it was directing calls properly. However there is an unusual location condition with the Navarre area. The local calling area is serviced by two LECs, BellSouth and Sprint. The programming will only direct to one LEC and since the phone physically resides in the BellSouth area, it directs this traffic to BellSouth.
