Item 14: Since receiving my certificate I have filed for and received a Fictitious Name of Trident Communications from the State of Florida and an Occupational License from Santa Rosa County. Please forward a copy of this letter to your records department. The records can be updated from "Derrell Fagan" to "Derrell Fagan dba Trident Communications" if your department sees a need to do so. I was surprised to see this item appear on one and not the other. After receiving your letter, I inspected the phone and it was directing calls properly. However there is an unusual location condition with the Navarre area. The local calling area is serviced by two LECs, BellSouth and Sprint. The programming will only direct to one LEC and since the phone physically resides in the BellSouth area, it directs this traffic to BellSouth.
